KLA Statement

TURKEY BOMBS YEZIDI MEDICAL CLINIC IN NORTHERN IRAQ

This week, while mainstream media focused world attention on the fall of Afghanistan to the Taliban and Afghan people desperately seeking ways to flee their country, a NATO member of nearly 70 years – Turkey – took the opportunity to intensify its ethnic cleansing campaign against Kurds. On the 17 August, Turkish forces shelled Tal Tamar, an Assyrian town in Hasakah province in north-east Syria, killing one child and a woman, and wounding 12 other people. On the same day, Turkey's drones struck a medical clinic in Sinjar (the Kurds' name for the region being Shingal), in northern Iraq killing nine people, and destroying the clinic.

According to Shingal's Autonomous Administration and Murad Ismael,
President & co-founder of Sinjar Academy and co-founder of Yazda, the nine
killed in the bombing of the medical clinic were eight Yezidis and one Arab.

Among them were five volunteer civilian medics (one being a doctor), and four
members of the local Sinjar Resistant Unit (YBS), members of the YBS having been
incorporated into the Iraqi Armed Forces' as the 80th regiment of the Popular
Mobilisation Units (Hashd al-Shaabi). All were survivors of the ISIS genocide of
August 2014. This bombardment came a day after Turkish airstrikes killed a local
Yezidi military commander and two of his bodyguards, and wounded others on their
way to meet Iraqi Prime Minister, Mustafa Al Kadhimi. Prime Minister Kadhimi was
visiting the region for the first time to commemorate the ISIS genocide seven years
earlier.

Targeting civilians and hospitals is barbaric, but also a war crime according to the Geneva Convention. Kurds around the world are deeply traumatised by Turkey's ongoing war crimes and support for Islamist extremist militants in northern Syria, Turkey and Iraq. Lastly, instead of issuing platitudes about preserving Iraq's sovereignty, we call on the Biden administration to block Turkey's frequent violations of northern Iraq's airspace. We call on the international community to implement a no-fly zone, If necessary, and take further action if Turkey continues to violate Iraq's sovereignty, and if Turkey continues to ignore ceasefire agreements with the US and Russia, and continues to consolidate its Islamist occupation of Afrin and other districts in northern Syria.
